The rest below are general meetings in 1961/62.


The President spoke on the lateness of general meetings to start! The very next meeting he is held up and late- the meeting starts without him!



OATLEY PARK POOL COMMITTEE REPORT.

The committee elected to explore the possibilities of the construction of an Olympic Size pool at Sandy Beach, have, after extensive investigation, submitted to Hurstville Council their proposal.

The suggested design is a standard olympic size elevated, reinforced concrete pool supported on pre-stressed concrete piles. The estimated cost of the project is £50,000.

The proposal, as submitted, has been referred to the Council Engineers for investigation and the Committee are awaiting the report with considerable interest.

A survey conducted in May revealed a 95% interest in the 'Scheme and it is the consideration of the Committee that, if Hurst-ville Council are prepared to assist this scheme financially, the residents of Oatley District will back the Committee Financially and by this joint action, the Memorial Pool will become a showpiece of the Hurstville Municipality.

The Site suggested to Council is that area now in use for competitive swimming.

With the summer season here, it should be clearly seen that the proposed pool would indeed be an acquisition to the District and the Municipality.

Your support of this project is of vital importance and there are many ways, in which you can assist the committee.

The Organising Committee meets every 2nd Wednesday of each Month in the Swimming Club Hall, Mi Mi St., Oatley, and a cordial welcome is extended to persons interested in the project.



THE HISTORY OF CATLEY AMATEUR SWIMMING CLUB

ORIGIN OF OATLLY PARK

Before going into the history of the Club we must consider the location where we compete.

On the 25th March 1887, 45.32 hectares of land was dedicated as a park and on the 29th May 1888 it was declared as a native animal and wildlife sanctuary.

Hurstville Council commenced the same day as the park was declared, the railway came through Oatley in 1886 so the park was declared when the population of the suburb was very small.

THE BATHS

The date of the construction of the first baths is unknown. Its site stretched from the edge of lane 6 down the outside of the turning boardto a point meeting a fence coming out from the main beach where there is a rocky outcrop.

During the depression era 1930-35 men on the "dole" did not receive any money instead they worked for it mostly on heavy laboring road work. As Oatley Park was undeveloped after nearly 50 years the council then placed a large number of men on Park improvements, this resulted in roads, the rock castle, the oval and the building of the baths as we know it.

The park was originally known as Sandy Beach, a name not known to the present population.

The park has always had two beaches and the northern one was originally outside the first baths and on the weekends when the tide was suitable fisherman used to bring in their boats to sell fresh fish to the public.

In the 30's 40's and 50's members used to catch prawns in the baths.

With the baths being 365 Yards long it has been recognised as the largest baths in Australia and the around the baths race every year would be the longest straight race in Australia inside a baths area.

One of the major problems has been to keep the baths sharkproof. Over the many years a fairly large wire mesh has been used. A large amount of wire was required but due to rust about 3 years was the life of the wire and it had to be replaced which was rather a expensive exercise for the council. With the large mesh users of the baths were often plagued with jelly blubbers with painful results for the users of the baths.

For a couple of years in the late? O's the club purchased a fishing net which was placed around our swimming area and allowing us to swim free of them. In 1980 Hurstville Council installed a fibre glass net of smaller mesh size which has been of great benefit to the public. Except for an odd jelly blubber it has kept the baths practically free of them and being rust free will last longer though it is showing signs of wear where the public are hitting it with boats or climbing up on it.

FORMATION OF THE CLUB

On the 15th January 1927 a meeting was held a Alderman Hedley Mallards house in Douglas Haig Street for the purpose of forming a Swimming Club.

The people who attended and were the foundation members of the Club were H. Mallard, P. Murray, J. Salmon, A. Stead, S. Christie, V. Kaysen, H. Cohen, B. Salmon, A. Auld, W. Jones, A. Wilson, T. Montague, J. Wilcox I. Prior, F. Smedley, C. Montague, G. Lyndon, L. Mallard, P. Phipps, W. Stevens, B. Shaw, D. Shaw, S. Hodgson, Misses V. Green, M. Smedley, V. Brown, A. Smedley, M. Murray, M. Crofts and Christie.

The Club was originally called and operated under the name of Oatley District Amateur Swimming Club until we were forced by the N.S.W. Amateur SwimmingClub in the 60's to drop the word District out of the name due to some regulation.

The first President was Hedley Mallard, Harley Cohen Scretary and Bill Stevens Treasurer.

I a rather unusual move for those days it was to be a combined men and ladies swimming club. This led to many clashes with the N.S.W. Ladies Swimming Association where policy was that men and women must not belong to the same club.

They said it was immoral and for a while when we ran swimming carnivals they insisted that only women were to be time keepers, judges and starters. When they rang the President they insisted they would only speak to a woman President. Eventually Ray Stevens and ex member Brian Ogle moved at Headquarters to disbandon the Womens Swimming Association and they now all belong to the mens Association.

The first membership fees were 50 cents Men, 30 cents Ladies, Juniors 25 cents and Senior Members 6d a race.

The first carnival was held on the 26th January 1927, and was opened by the Mayor of Hurstville D. Webb. All city and suburban newspaper reporters attended and gave a tremendous amount of publicity.

The next meeting was held at the home of Mr & Mrs Wilcox in Douglas Haig Street where there was more room.

Due to increasing membership and many socials being held a large galvanised shed was rented in Mulga Road. Many meetings and socials were held in this shed and eventually it was decided to purchase land on the corner of Woonona Pde and Myall Streets Oatley. An offer of \$10 was made to Hurstville Council to purchase an old dressing shed from Oatley Park. This was dismantled and shifted to the land and with other materials the present hall was erected and beside it a tennis court. Members then completely furnished the club with piano, urns and furniture. It was actually the forerunner of clubs that we know today.

To pay for the land a rather unique scheme was installed, it was called the Land Scheme. For 10 cents a week each child could be a member until the age of 16 years.

During the 1930's this was a great boon as during the "Depression Years" money was very scarce.

The club room became the social centre of West Oatley, which looking back was a very isolated area. You had to make your own entertainment. Meetings were held twice a month and every now and then they ended up in wild disarray. Members would appear to argue about anything and it was considered a good night out. Card evenings were held, dances and parties and once a week lifesaving classes were held under the eagle eye of Dud Shaw. For a while the club was the best lifesaving club in N.S.W. winning the highly coverted Kelso King Shield beating the N.S.W. Police.

One of the greatest highlights of the season would be our annual picnic to Thirroul. The club would hire two railway carriages with the train stopping at Oatley to pick up the large crowd. Community singing was one of the main features of the trip.

Pre War there were only two other clubs operating in the St George area kamsgate & St George operating out of Brighton Baths. The Club also played water polo and were fairly successful playing at Ramsgate Baths on a Sunday Night.

Due to the small number of clubs operating there was not many carnivals but they were keenly contested.

The best swimmers in these years were Cheshire Fuimini, Fred & Jack Smith The Davies Boys, Roy Rushworth, Jack Lawler and not forgetting The Belcher Girls. Cheshire was an outstanding sprinter, swimming 50 yards in 25 seconds which was an outstanding time and even by todays standards pretty fast, and he swam that time a a junior.

Then came the 1939-45 war. Many members enlisted and the club became mostly operating with juniors. Three members were killed and they were all Air Force, Jack McDowell, Cec Ricketts and Ian Thompson. During these years the club was held together by Bill Stevens, Ron Stevens, Noel Hammond and Tim Murphy.

When the members returned from war service the club expanded again and pre war activities were expanded. Monthly dances were held and a

This gave the club plenty of publicity and became West Oatleys newspaper and was available at local shops and delivered to local houses.

Fountry trips to Bathurst, Orange Dubbo and the Entrance were greatly enjoyed by members. As many as a dozen vehicles would take members away for a weekend to compete against country Clubs and enjoy a social outing as well.

Our club was very strong in "Club Swimmers" particularly in the Seniors and during these trips we were very successful. Members enjoyed themselves immensely and when members meet they still talk about the various incidents that happened. The trips to the Entrance Club were the most hilarious. With the co-operation of Fred and Ade Montague and the Club we rented a cottage for the weekend and as many a 60 members would attend. Water pistol fights became famous and our subsidiary Woronora Club (The Fowler Boys) always attended. Who would forget "Chook" Fowler and his beat up cars.

FLIX FOR NIX

During the early years the "Flix for Nix" era was born. Every month the club arranged Films from Shell, Health Department, Travel Companies and the State Film Library.

The Club room used to be packed by members and funds were raised by selling drinks etc, and members led by Jim Burke placed the signs in chalk around the district. This entertainment went on for many years and gradually faded out when television took over.

For a couple of years, 2 nights a week physical training classes were run for members by Frank Jorian, a well known coach.

The Club formed a Junior and Senior Soccer team which had mixed success but better results were obtained by the Ladies & Mens Basketball teams.

Many bus picnics, socials and some classical launch picnics up the Woronora River were held. Members still talk about the time when the boats were taken up at high tide but unfortuneatly the tide went out and the members had to carry the heavy wooden boats down the river.

Membership reached a peak in the late 50's and 60's but today we still have a steady membership consisting mainly of family groups and I think we could be one of the few clubs where father, mother and the children race together.

LEARN TO SWIM

For children learning to swim today there are plenty of facilities, Government Sponsored on school holidays, private coaches etc, but in the 1950's and 1960's the Learn to Swim campaign was conducted by Swimming Clubs. There were not any real public pools, a very few coaches and so the club used to teach at the baths on Saturdays allowing for the tide. Our facilities were very poor for teaching the children but hundreds of children were taught. It was nothing to have 100 children turn up. All club members helped and the chief organisers were Mrs Phil Pomfret, Mrs Peg Rogers, Les Bodds, Nola Stevens and many more members both Junior and Senior.

As more local facilities became available we were required less and it eventually faded out.

PARK RANGERS

The most famous of the Rangers (Caretakers) was George Prentice. He was employed by Hurstville Council practically since the inception of the baths. He was absent for a while during the war years but back again after the war for many years. He was a real Character and many stories are told of his unusual behaviour. The kids in the early days worried the life out of him, floating his wheelbarrows in the water, adults not parking their cars properly. Every one knew George but no one can deny he was a great worker. A lot of the rock work around the baths was placed by him and he kept the place spotless. After George retired we had Jack Neild for many years and since then we have had a bit of a change with many rangers. All through these years the club has greatly appreciated the assistance and co-operation of the rangers and we have co-operated in keeping the baths clean and controllong people who create a nuisance.

BOTTLE DRIVES

In the late 50's and 60's the club to raise funds decided to have bottle drives organised by Bill Mitchell, they were a great sucess. We have now reduced to a bottle yard at the club and they have been a ready source of income to the Club.

TURNING BOARDS

The supply of a turning board and also starting wall has been a major problem to the club until recent years when Hurstville Council has supplied a good concrete starting wall and a large steel floating pantoon.

The first finishing wall was a permanent wooden fixture and lasted for many years though repaired regularly. This eventually collapsed and we had some real trouble for many years.

We had a floating pontoon made up of 40 gallon drums. That lasted for a couple of years and then collapsed. Next was an electric light pole we chopped down but to our surprise it did not float. It was a problem with the pole but eventually the Council supplied a couple of steel pontoons until they rusted away and we have our present one.

DRESSING SHEDS

The first one was half way up the ramp down to the baths and a piece of the concrete floor can still be seen and also a couple of slots in the rock where the rafters went.

The shed was very small and would not hold more than a dozen people at a time and with large crowds at the baths you had to queue up. Then the ramp was put in, the shed was pulled down and two large tin sheds were built on the flat, one for the men which had a partition in it for the club to put their lanes in.

These sheds were not the best, bare floors no showers but they served there purpose.

In 1959 the present sheds were built by Hurstville Council which were a great improvement both from the public and club view.

The facilities have been a great help to the club as basically we are a social swimming club.

SWIMMERS

As we are a swimming club, we cannot go without mentioning them. We have and have had all ages from 3 years old to swimmers in their 60's. We have had slow and fast swimmers but over the 55 years we have escaped the fanaticism of other clubs who concentrate on their champions and not on the club swimmers. We have always operated as a family club, dad mum and the kids and our main object is to enjoy ourselves and I think we have done this remarkably well. We would have the largest senior membership in the district.

But as in any sport there will be always the swimmers who are natural athletes and stand above the rest.

To name these swimmers is very hard, but in my opinion and many may disagree with me, I would nominate the following, Cheshire Fuimini for (pre war) a sprinter, Frank Stevens for backstroke who competed in the Empire Games and Australian Junior Champion, Bob Bouffler probably our pest all round swimmer with the greatest potential, Richard Quinn a versatile all round swimmer, John Stevens as a butterfly swimmer, for an older swimmer Jack Campbell, and last but not least Herb Akerman. Herb has been in the club for 25 years and he is swimming as fast as he was 25 years ago. In the ladies our most outstanding would be Carol Stammer, Win Belcher, Diane Campbell, Helen Thibou and Val Lynch.

MEMBERSHIP

One feature of our club has been the long time members have competed. The Stevens, John Ron and myself have been competing for 50 years which is something of a record. There are members who have been competing over 20 years, Jim Yeomans, Herb Akerman, Col Lynch, Val Lynch & Alan Smith.

It is in this long period that the club strength is. The members have raced, then their children and grandchildren. Thousands of members have gone through the club, and it is very pleasing to meet people who were in the club many years ago and still ask about us and still read the results in the "Leader". These ex members still have fond memories of the club and still talk about the picnics barbeques and socials as if it was yesterday.

OTHER CLUBS

Prewar we had other clubs to compete against, North Ramsgate & St George (Brighton Baths). We competed regularly against them at swimming and water polo. After the war more clubs sprung up with the building of more Olympic Pools. We used to compete regularly at carnivals but over recent years not at so many as unfortunately the other clubs do not have many senior swimmers, as our strength are in the seniors we have drifted apart from the carnivals as they seem to have lost their social aspect. I think that with large numbers of clubs and members practically 100% juniors the carnivals take too long.

OFFICIALS

The club cannot operate without officials. Reading through old minute books, names keep appearing year after year. Bill Stevens, Fred Meyers Bernie Howard, Jack Maples, Harold Coates, Bill Mitchell, Ron and Esma Holt. Jim Burke, K. Patterson, Bob Bennett and many more. But without them no club operates.

PUBLICITY

Over the years we have had great co-operation from the local media who have always published our results which lets the public know we are still operating. In recent years we must thank the St George Leader for their assistance.

HURSTVILLE COUNCIL

We must not forget to mention Hurstville Council, for without their foresight back in 1887 there would be no baths and no swimming club. We can safely say Oatley Park is one of the most pleasant places to have our unusual swimming club

We have diffence of opinions over the years with the council but our both objects is to make the baths more pleasant for the public.

The large baths have always created problems but it is a unique baths and the only type in Australia and we must thank the council for their co-operation in helping us with our facilities for racing. It could be improved but due to unique problems it is a problem and we are working on it.

SUMMING UP

We are a unique club in the swimming world, being for members to enjoy themselves both socially and swimming. Whether we be fast or slow swimmers it doesnt matter. We are a family club and our long serving members back this up.

We invite all locals whether they can swim or not to come along and join us.


Well there you have a rundown of all our main competitors so I hope you now have all the information needed to beat your opposition this season.

At the beginning of each season we have our award presentation for social achievements of the previous year. As always it was a very closely fought affair but I think you will agree the winners are worthy of their awards.


The socializing award went to Mrs Willis for her uncanny ability to join in and have fun at parties.



They are just two of the 80-odd They are just two of the 80-odd
Oatley Amateur Swimming Club
members who would rather take
the plunge in a salty, bush park
pool than line up on the blocks at
an Olympic-sized venue.

Each spring and summer Suntay, club members gather at
Oatley Park for their version of a
race meet.

Nevertheless, Oatley's formula has proven a winning one. This Saturday, the club celebrates its 70th birthday.

It was founded by a group of returned World War I servicemen at a time when river inlets were being netted off all over the district

for community swimming pools.

The river pools provided cool relief in summer and a social outlet for families who did not have the transport to get to the Olympic-sized pools at Enfield, North sized pools

Sydney and Granville.

But after World War II, the balance shifted. More households had cars and more council pools Camaraderie, rather than competitiveness, is the driving force and freestyle could just as easily mean dog paddle.

"All the other clubs are too competitive for us," he said. "We're not in it to win anything. We just swim for the fun of it."

had cars and more council pools were springing up in the suburbs. The river pools became neglected as swimmers flocked to the crystal-clear, tideless, artificial swimming holes.

Oatley, however, proved an exception. Mr Stevens, who has

said Oatley owed its popularity to its tranquil setting and lack of

stranguil setting and lack of sporting prowess.

"Most of our swimmers wouldn't be of much interest to other clubs because they don't care if they win or lose," he said.

"We have kids who are just learning to swim and older people who just want to relax. They can


who just want to relax. They can wear flippers for all we care. It's the social aspect of the club that people come for.

Welcome to members, ex members and friends of Oatley AmateurSwimming Club.

Back n 1926 when a group of people decided to do something about the social life of West Oatley citizens, I wonder if those same people would have realised that 75 years later, the club would still be operating.

I would like to take you all back to 1926 to show you what Oatley was like. The populaton was scattered over a large area, with many paddocks and houses nterspectrised amongst them. Oatley was then split into many areas, with East Oatley, West Oatley, Neverfail Bay, Gungah Bay, ewfish Point, etcetera, but Oatley Weest was isolated from the other areas by bad roads. Electric light was introduced in the 1925 period. The electric light poles were pulled into position by bullock teams and a large number of houses still had gas lights.

Entertainment was nil. No hotels (one was built in the early thirties), no picture theatres, no dance halls and radio stations were only just being thought of. The BBC did not commence operating until 1932. Foundation members within the community decided that they would form a club, which would cater for social and sporting activities.

The baths were completed in 1917 - much smaller than what we have now - and the surroundarea was in its natural state; no stone wall or footpath in existence. The dressing sheds were shocking. There was just enough room to take, say, ten people, and they were halfway up the hill from the present site; the shower was a tap! Later two larger ones were built and, in 1959, the present sheds were erected; now we have hot showers, toilets and tiling!

Racing facilities were prmitive and photos show lanes tied to the wire fence, and back to the Shoreline. In the 1930's the promenade was built, and this has not changed much, except for the Cement path, part way.

The pontoon that we have today is much better – there are those swimmers who will remember The first one was like a wharf, and then we had a t elegraph pole held together by two pieces Of railway line.

One of the original aims was to have good social activity and it makes interesting reading to go Through the Minute Book down through the years. The hall was bult around 1928-30 on land Bought and was used for all sorts of activities, such as birthday parties, weddings, life saving Classes, table tennis, physical fitness classes, card nights, fetes, meetings twice a month, And remember Flix for Nix nights were held monthly for many years.

The club was always short of cash. Records show that a profitable night might have been Eighty cents, two dollars or three dollars, and ten dollars was a record. In 1970, the hall was Leased out as a kindergarten, and our financial problems eased.

With our bottle drives, we have provided excellent trophies, the enjoyment of barbeques, plus Tea and coffee making facilities.

Over the years the club has been involved with various sports. In 1938 a soccer club was Formed called the All Saints Oatley West – which is now a thriving club, a basketball club for Both male and female; water polo teams, physical training teams, learn to swim, etcetera. The swimming club has always been a strong senior club. Earlier there were many juniors, But with the bulding of olympic pools, they have tended to drift away. However, it is still a Strong family club.

Many good swimmers have passed through our ranks over the years and I have been asked many Times to name the best swimmers. It is very hard to this as swimming times have decreased Substantially. I do find it strange that our club never won many district championships, and the Only names that can be brought to mind would be my brother Frank Stevens, who won district, State and Australian junior and senior backstroke championships, and competed in the Empire Games in 1950. Pre-war I would say that Cheshire Fulmini would have been our best Swimmer. After the war we had many "fast" club swimmers, but the most outstanding ones I would say, would be Bob Boufler (any stroke), my brother John in breaststroke and butterfly, And with John Coleman over all strokes and distances. The ladies who have shone over the years Have been Carol Stanners and, of course, Val Lynch. We now have the best lady swimmer, she Is certainly giving the men some problems, and her name is Julie Rohl.

The activities of the club now centre around the club room, down at the baths. There are Monthly barbeques, daily swims, competitive racing, and regular outings for what we call the "retirement club."

Praise must be given to the many officials who, over the years, have carried out their work with Efficiency and enthusiasm. The club would not be in the strong financial position it holds Today if it was not for the foresight in the past in buying land, erecting a hall and never Getting into debt. They were foresighted men such as Bill Stevens, Hedley Mallard, Jack Maples, Fred Myers, Dudley Shaw, J. Postill, S. Auld and Fred Walker.

When the lady who owned the kindergarten decided to retire, we were left with a serious Financial problem because, over the years, she had paid all our expenses, i.e. council rates, water Rates, insurance, plus running the club. As the club did not require this facility once the kinder-Garten closed, and there was no income, the financial committee decided that we would have to Sell the land and use the income from investments to finance the club. The money received from The sale of the land was far greater than we had expected.

As we are an incorporated company, we are restricted with what we can do with the money. Fortunately we are exempt from tax and, therefore, all moneys can only be spent on the Promotion of swimming, and club members make any decisions as to what they would like done.

If any of our old members live locally, what about joining us down at the baths on a Sunday?

SWIMMING mates Ron and Ray Stevens have braved the waters of Oatley Baths every day for 60 years

SENIOR swimmers Ron and Ray Stevens should be all washed up—or at least a little waterlogged.

at least a little waterlogged.

Between the two of them, they have swum about 80,000km over the past 60 years as members of Oatley Swimming Club, the oldest club of its kind in St George and Sutherland Shire.

But the aquatic pair claim there's many a lap left in them with Ron, 65, and Ray, 71, each clocking up at least one kilometre a day in the Oatley Park baths.

Ron and Ray, who are not related, joined Oatley Swimming Club in the early 1930s, after its formation in 1927 by a group of World War I veterans eager to provide locals with a sporting and social oulet.

oulet.

They were among 130 past and present members who attended the club's 65th anniversary reunion dinner at the Masonic Club, Mortdale.

The club's strength has always been family membership — encouraging par-

ents, children and even grandparents to swim together.

ents, children and even grandparents to swim together.

In fact, with more than 60 per cent of its members tagged as "seniors", the club awards handicaps far more often than it does prizes for shattered records.

"We're a social group as much as we are a swimming club," said Ron, still in his trunks after a brisk morning dip.

After all, this is a club where the number two item on its list of "rules" states:
"A chocolate is given each race meeting to the entrants of juvenile races."

About 60 members regularly swim competitively and socially in the club's saltwater pool tucked away in a serene corner of Oatey Park on Jewfish Bay. Two of the club's members are physically handicapped.

While no Olympians have sprung from the club's waters, former member Frank Stevens was a finalist in the 1950 Auckland Commonwealth Games, missing out on the Olympic squad by one stroke.
